APPLICATION DEADLINE/SELECTION PROCESS: Application Deadline is **August 31, 2021**. The New Jersey Pig Jig committee reserves the right to accept or reject entrants at its sole discretion.

FEES: The fee is as follows and includes two (2) chairs, and two (2) complimentary general admission tickets. **No refunds will be issued.**

Extra 8' tables	\$20/each

SILENT AUCTION: As part of the fundraiser, we are asking each vendor to donate an item to be used in our silent auction at the event. Funds raised from the silent auction will benefit NephCure Kidney International.

SPACE ASSIGNMENTS: All spaces are located on grass. Spaces are not vehicle accessible for setup. Vendors should be open for business at 1:00 PM, and should not begin breakdown before 6:00 PM. Vendors are responsible for their own displays. All garbage or refuse should be handled by Vendor and not left behind at your booth.

VENDOR PARKING: There is a pay parking lot that can be used by Vendors, or street parking is available. Handicapped vendor parking is in a designated location within the parking lot.

WAITING LIST: Eligible applicants who did not receive a space assignment will be asked to join a waiting list. Available spaces will only be filled from this list.

OTHER INFORMATION: All exhibitors are responsible for collecting and reporting State and Local Sales Tax. There are no rain dates in case of inclement weather.

TERMS AND CONDITIONS

- 1. SETUP/BREAK DOWN:** All Exhibitors must be set up and **ready to sell by 1:00 PM** on the day of the New Jersey Pig Jig. Exhibitors may **begin setting up at 11:00 AM** the day of the event. Break down can start no sooner than 6:00 PM and must be completed by 8:00 PM. No vendor is to close before 6:00 PM. Sellers are responsible for their selling spaces. *Before leaving, be sure your area is clean and trash-free.
- 2. STAFFING:** Exhibitor tables/ booths must be manned at all times and intact until vendor portion closes at 6:00 PM. NephCure Kidney International (NKI) is not responsible for merchandise or display materials.
- 3. EXHIBITOR ITEMS:** Items for sale at the Exhibitor's booth must be predominantly handmade by the Exhibitor. Each Exhibitor must submit a few photographs of his or her craft(s). If participating as a crafter, the New Jersey Pig Jig committee reserves the right to have items removed that are considered not appropriately handmade. Items cannot be simply purchased for resale.
- 4. EXHIBITOR RESPONSIBILITY:** Exhibitor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. NKI expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each exhibitor is responsible for the conduct of his employees and/or representatives and activities must not detract from the image or welfare of the event.
- 5. EXHIBITOR SPACES:** Exhibitor spaces will be assigned. Placement, flow and competition will be taken into consideration to provide the best experience for event attendees. If you have special space needs, please include your request with your application and we will make every effort to accommodate you. Spaces are reserved on a first-come first-served basis. Vendors must ensure that none of their display equipment extends beyond their space; this includes any rails, stands or additional equipment.
- 6. ONE BUSINESS PER SPACE:** Only one (1) business per space reserved; space may not be sublet or shared without prior approval of an authorized staff of NKI.
- 7. ACCEPTANCE:** The New Jersey Pig Jig committee reserves the right to decline any application for space if it deems such action to be in the best interest of the New Jersey Valley Pig Jig.

8. **PAYMENT:** The full payment is a non-refundable registration fee for the selected space and is due with the submission of this agreement. This fee will be used to cover advertising and other incidental costs associated with the production of this event, and tent/table rental (if requested by vendor).
9. **CHAIRS:** Two (2) chairs will be provided. Each Exhibitor may furnish additional chairs, tables, stands and/or exhibition props. All spaces will be on grass; it is advised to bring along shims, or blocks of wood to level out the tables, since some areas may include un-level ground. No electricity will be available.
10. **CANCELLATION OF SPACE:** Application fees are not refundable. NKI is not liable if weather or other conditions prevent the Exhibitor from attending and fulfilling the contractual obligation as an Exhibitor. No refunds will be made for weather, accident, health or other causes for non-participation.
11. **INDEMNIFICATION:** Exhibitor agrees to indemnify and hold harmless NKI and its agents, representatives and volunteers from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the Exhibitors at the New Jersey Pig Jig.
